

DATA PROTECTION NOTICE – Personal details of experts involved in Europe's Rail European DAC Delivery Programme [PO-3-04]

Personal details of experts involved in Europe's Rail European DAC Delivery Programme involves processing of personal data, which shall comply with Regulation (EU) N° 2018/1725¹ (the "Regulation").

This data protection notice explains how the Europe's Rail Joint Undertaking (here after referred to as EU-Rail) uses any information you give to us, and the way we protect your privacy. Furthermore, it describes the rights you have as a data subject and how you can exercise these rights.

EU-Rail protects the fundamental rights and freedoms of natural persons and in particular their right to privacy with respect to the processing of personal data.

We provide the following information based on Article 15 of the Regulation.

What is the purpose of the processing?

Personal data is collected via EU Survey Tool, the "DAC Identification Grid for Operation" (<u>https://ec.europa.eu/eusurvey/runner/DACIdentificationGridforOperation</u>) and "DAC Identification Grid for Governance" forms for the purpose of identifying competent experts who will represent the different parties' interests involved in the European DAC Delivery Programme and actively contribute to the creation of technical outputs.

Additionally, personal data is collected for the purpose of informing the general public about the programme experts involved in the European DAC Delivery Programme (<u>https://rail-research.europa.eu/european-dac-delivery-programme/)</u>.

For experts, observers and representatives nominated to the DAC Supervisory and Programme Boards, personal data is collected for the purpose of identifying potential conflicts of interests and ensuring confidentiality according to the Rules of Procedure of the respective boards.

Which personal data do we process?

Personal data:

- Personal details (name, surname)
- Job title and employer
- Country of residence/employment
- Language skills
- Contact details (e-mail address, phone number)
- Photos (i.e.: for programme managers of DAC)
- Past and current activities, current financial or family interest or actual or potential conflict of interest situations for nominated members of DAC Supervisory and Programme Boards)

Why do we process your personal data and under what legal basis?

Personal data:

- Explicit consent Article 5 d) of Regulation 2018/1725
- Public interest Article 5 a) of Regulation 2018/1725

Who is the controller and other actors involved in the processing?

How is EU-Rail processing the personal data?

How do we protect and safeguard your information?

- Data kept according to the security measures adopted by the European Commission
- Access control and technical measures such as physical locks and/or secure connections and firewalls (i.e.: conflict of interest situations members of DAC Supervisory and Programme Boards)
- Secure transfer of data
- Staff dealing with this processing operation is designated on a need-to-know basis

Who can access to your personal data and to whom is it disclosed?

- General public: visitors of the EU-Rail DAC webpage (only parts of personal data i.e.: name, surname, photos) for the purpose of informing the general public of experts involved in the European DAC Delivery Programme.
- Data subject themselves
- EU-Rail Executive Director and EU-Rail Programme Office (declaration of conflict of interest situations for nominated members of DAC Supervisory and Programme Boards only)
- European Commission and its services: Authorized staff (declaration conflict of interest situations for nominated members of DAC Supervisory and Programme Boards only)

What are your rights and how can you exercise them?

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. In addition, you have the right not to be subject to a decision based solely on automated processing of data, including profiling, if such decision has legal effect on him or her, except for certain situations, such as entering into a contract (as required by articles 14-16 & 24 of EU DPR Regulation).

Information on action taken on the data subject's request to exercise her/his rights shall be provided without undue delay and in any case within one month of receipt of the request. In case of complex or voluminous requests, this period may be extended by another two months, in which case the JU will inform the data subject.

In case data subjects wish to exercise their rights, they should send an email to the EU-Rail Data Protection Officer at data-protection@rail-research.europa.eu.



How to withdraw your consent and the consequences of doing this

Data subjects have the right to withdraw their consent at any time by sending a written request to the above-mentioned email address. Please note that withdrawing your consent does not affect the lawfulness of any processing based on your consent before this consent is withdrawn.

Possible restrictions as laid down in Article 25 of the EU DPR Regulation can apply.

How long is the data retained?

- 5 years: personal details of experts names published on the EU-Rail web site, unless mandate extended; declaration of conflict of interest situations for nominated members of DAC Supervisory and Programme Boards
- Until the data subject leaves his/her expert role or one month after the end of the European DAC Delivery Programme, whichever is the earliest.
